FUNDING AGREEMENT FOR BIRDWELL PRIMARY SCHOOL

I am pleased to inform you that I have agreed to enter into a Funding Agreement with you to allow Birdwell Primary School to convert into an academy. My officials will forward a copy of the executed Funding Agreement to you.

The date of conversion, when the school will open as an academy, will be 1 April 2023. I am writing to Barnsley Metropolitan Borough Council to instruct it to cease maintaining the school from that date.

If you have notified the Department of any additional leases or subleases the academy trust wishes to grant on conversion, these will also require my consent (according to the terms of both the Funding Agreement and the relevant legislation), and we will soon write separately in relation to this.

FUNDING AGREEMENT FOR BIRDWELL PRIMARY SCHOOL
